- 6. Describe the changes in copyright law over the years. Compare today's copyright terms to original copyright terms. Explain why or why not the copyright terms of today are (or are not) in compliance with the US Constitution.
- 7. Describe the concept of fair use. How has digital rights management affected fair use?
- 8. Describe why it can be difficult to recognize an ethical issue.
- 9. Do you believe the Google Books project is a fair use of copyrighted material? Justify your answer.

Summarize the rulings of the U.S. District Court, the U.S. Court of Appeals for the Ninth Circuit, and the U.S. Supreme Court in this case. Include in your discussion the precedents cited by these courts.
- 13. Nancy Leveson and Clark Turner wrote, "There is always another software bug." Relate this statement to the saga of the Therac-25 radiation therapy system.
- 14. Some online retailers are using information gathered about their customers to offer different prices to different people. What is your position on the morality of this strategy? Justify your answer.
- 15. Some say police should be required to have a search warrant before using a drone to look inside the windows of someone's house. Others say police should be able to use a drone to collect evidence that will enable them to get a search warrant allowing police officers to enter the house. Which position do you support? Why?
